If you request the JSS to collect a payment, confirmation of the amount and date will be given to you at the time of the request.
- If an error is made in the payment of your Direct Debit, by JSS or your bank or building society, you are entitled to a full and immediate refund of the amount paid from your bank or building society. If you receive a refund you are not entitled to, you must pay it back when JSS asks you to.
- You can cancel a direct debit at anytime by simply contacting your bank or building society. Written confirmation may be required. Please also notify us.

Subscription Reminder



Membership subscriptions are renewable on 1st January each year.

Direct Debit is the simplest and lowest cost method of payment for the Society to administer. 65% of members already help the Society by paying this way. If you would like to join them and pay this and future subscriptions by direct debit, please complete the form opposite.

If you already pay by direct debit you need take no further action and your subscription will be debited from your account on the first working day of the year.

If you would prefer to make your payment by cheque made payable to Jacob Sheep Society, please send your remittance together with the tear off slip below.

Another way in which you can help the Society is to complete the attached Gift Aid form. The Society can then reclaim tax on your subscriptions and donations. The only criterion is that you need to be a UK taxpayer. Please help us to maximise this vital boost to our income.
